ORDER

In the Government Order read as fifth paper above, it was ordered that the dependents of Ex-servicemen who are permanently disabled due to disease or accidents while in active service and discharged on pension on that account would also be eligible for concession of inter-district transfers. Later, Government reviewed the orders on inter-district transfers and in the Government Order read as sixth paper above ordered, in supersession of all the orders then existed, that inter-district transfers would be allowed only after completion of five years service in the district of recruitment. The only exception to this rule, as per the above Government Order would be cases of transfer to the district of choice of candidates advised from district rank lists to headquarters vacancies and that of near relatives/dependents of serving soldiers/soldiers killed in action or died while on duty in field/forward areas.

Government are now pleased to order that, the relaxation in five year rule for inter-district transfer granted in G.O.(P)No.36/91/P&ARD. dated:2-12-1991 will be extended also to the dependents of Ex-servicemen who were

permanently disabled due to disease or accidents while in active service and discharged on pension on that account.


