ORDER

As per the G. O. read as 5th paper above the number of seats for T. T. C. Course reserved for Ex-service personnel was fixed as 60 (6 in each Revenue District). Nothing has been mentioned in this G. O regarding the reservation of seats for the families of Ex-servicemen. As per the GOs read as 3rd and 4th papers above 20 seats (2 seats in each Revenue District) were reserved for members of the family of Jawans for T.T.C. course 69—71, but this reservation was however discontinued subsequently because the orders in G. O Ms. 41/70/Edn. dated 20-1-70 did not make specific mention about the reservation of seats to dependents of Jawans. The Secretary Rajya Sainik Board in his letter read as 6th paper above has requested that the children and wives of Ex-servicemen may also be included in the seats reserved for Ex-servicemen for the above course. The Director of Public Instruction has suggested that in addition to the seats reserved for Ex-service personnel, 2 seats in each Revenue Districts may be reserved for families of Jawans, since such categories of personnel enjoyed the benefit previously.

2. Government have examined the proposal in details in consultation with the Kerala Public Service Commission and they are pleased to issue the following orders in regard to the reservation of seats for TTC course to Ex-service personnel and dependents/families serving Jawans.

- (i) 6 seats in each Revenue District will be reserved for Ex-service personnel for T. T. C course. The seats left over after the selection of Ex-service personnel will be assigned to the wives and children of these personnel subject to the condition that they should have put in a minimum service of five years in the defence forces.
- (ii) 2 seats in each Revenue District will be reserved for the members of the family of Serving Jawans.
- (iii) If sufficient number of applications are not available from dependents of Jawans, Ex-servicemen and dependents of Ex-Servicemen in any year the remaining seats will be filled up by other eligible candidates.

3. Orders issued in G. O. Ms. 41/70/G. Edn. dated 20-1-70 will stand amended to the extent indicated above.
